Treasurer's Report for the Period 1 July 2020 to 30 June 2021

The Koo Wee Rup & District Motorcycle Club achieved a solid financial result in FY21, ending the Financial Year \$72,367.99 favorable as compared to the previous Financial Year.

This is an outstanding result, at a time when many sporting clubs and community organizations were experiencing financial difficulties, especially considering the Club's decision to support its loyal members by rolling-over Memberships (for existing members).

Key revenue call-outs contributing to the solid FY21 result include a number of Grants (including a new Tractor for the Club), the solid performance of the McGregor Rd RPA Track and the hosting of Rounds 1 & 2 of the AORC at Golden Beach*. A big 'thank you' message is extended to all Club members!

There is no formal requirement for the Club to have its finances independently audited and this has not been done for FY21, but is under currently consideration for the future by the Committee.

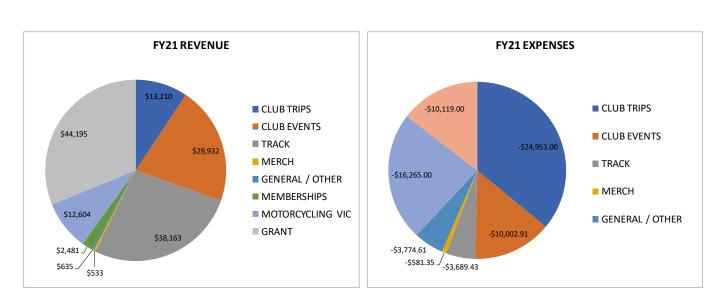


Chart 1 | Breakdown of FY21 Revenue and Expenses
